Official Car Raffle Rules 2017

Fundraiser for Kelly Community Organization, Inc. and Kelley Station Community Center and Park.

1. Eligibility

- a. Must be 18 years or older to purchase or participate in this raffle.
- b. Void where prohibited
- c. Agree to abide by all of the rules and conditions contained herein, as well as all applicable local, state and federal laws and regulations.
- d. Agree to release Kelly Community Organization, Inc., and Auto Master's and their directors, officers, agents and employees from any and all liability with respect to all aspects of the raffle including, but not limited to, the selection process.
- e. Kelly Community Organization, Inc. committee members and employees of Auto Masters are not eligible to win.

2. Ticket Purchases

- a. Ticket donation price **\$5 each** (U.S. Funds only).
- b. No limit on the number of tickets you can purchase.
- c. No more than **5,000** tickets will be sold.
- d. Ticket purchases are not a tax-deductible contribution under current IRS regulations. For complete information, the purchaser should consult their tax advisor.
- e. Purchaser of raffle ticket(s) must have their name, address and phone number legibly on each ticket. If more than one name is listed on the ticket, the first name listed shall be considered the "entrant".
- f. Entrant shall retain their ticket stub. In the event of any dispute or controversy concerning the winner of the drawing, entrant will be required to produce their raffle ticket stub.
- g. One (1) prize will be awarded.

3. Prize

- a. **2007 Blue Mitsubishi Eclipse** (VIN number 4A3AK34TX7E023834), **valued at \$8,150.00**
- b. **Winner accepts the car in AS-IS condition, no warranty on the car, its mechanical functions or repairs are implied or expressed.**

4. Drawing

- a. The official drawing will be held at **2:00 pm**, on **Monday, August 21, 2017**, at **Kelley Station Park 7490 Old Madisonville Road, Hopkinsville, Kentucky on the Auto Master's stage**
- b. Need not be present to win.



5. Winner

- a. If winner is not present at time of drawing, winner will be notified by phone or by mail based on the information received on the ticket.
- b. Name of winner will be listed on the website kellyky.com
- c. Winner will allow the Kelly Community Organization, Inc., and Auto Master's to use their name, likeness, and any statements made by them regarding the prize for advertising or publicity purposes without compensation.

6. Taxes and Other Costs

- a. All tax obligations, including withholdings on cash prizes are the sole responsibility of prize winner. The winner is responsible for taxes, license, registration, insurance or fees associated with prize won.
- b. Winner is responsible for federal income tax implications based on the fair market value of the vehicle.

7. Awarding of Prize

The Kelly Community Organization, Inc. shall not be subject to any other obligations or liabilities whether arising out of breach of contract, warranty, tort (including negligence) or other theories of law, with respect to the car. Without limiting the generality of the foregoing, the Kelly Community Organization, Inc. specifically disclaims any liability for property or personal injury damages.**
